ODOR ELIMINATOR 4058

Odor Control Solution

General Description

ODOR ELIMINATOR 4058 is an environmentally safe, liquid, malodor eliminator and neutralizer used for industrial based odors consisting of sulfides, mercaptans, amines, valeric and butyric acid, ammonia, and other strong malodors typically found in landfills. **ODOR ELIMINATOR 4058** is a concentrated compound that works on "contact" to entrap malodor molecules. This unique material "surrounds" malodor molecules to permanently encapsulate them and the process of odor elimination occurs immediately upon contact with offensive odor molecules. **ODOR ELIMINATOR 4058** is formulated with synergistic fragrance to complete a deodorizing product.

Application

ODOR ELIMINATOR 4058 must contact the malodor to be effective. The method of application is very important. **ODOR ELIMINATOR 4058** can be batch treated into the liquid malodor source or atomized and/or sprayed into the atmosphere for complete neutralization of emissions. Due to varying concentrations in liquids, titration of solutions with **ODOR ELIMINATOR 4058** is recommended to get precise treating ratios. Generally 1oz. per gallon of liquid is sufficient to neutralize liquids. For air borne applications, 1/4 to 1 oz. per gallon of water dilution is recommended. For extremely odorous conditions, **ODOR ELIMINATOR 4058** can be used as provided or diluted to effective concentration with water and applied via soak or atomizing spray. For initial landfill application, 1:500 dilution is recommended using 10 - 50 micro atomization. When used as a cleaner, dilute 1:4 to 1:10 in water.
