General Description

STW 75C is a heavy duty powdered detergent compound formulated for washing passenger cars and trucks in fully or semi-automatic car wash systems. **STW 75C** has proven to be the choice for mobile pressure wash operators when multiple trucks must be washed one after another.

STW 75C is a mild alkaline powder, specially blended to provide maximum penetration and run-off of soils, minimizing brushing and hand-mitting. **STW 75C** dissolves readily into water; simply place powder in a bucket or drum and add water with a hose to mix in quickly. **STW 75C** rinses leaving little to no spots, is easily removed if solutions dry on painted or glass surfaces, does not contain any EPA rated hazardous ingredients and all surfactants in the product are completely biodegradable.

Application

For hand washing or ready to use solutions, use 1/4 to 1/2 ounce of **STW 75C** per gallon of water depending on equipment and soil. In automatic car washes or mobile pressure wash systems, use 3 - 4 ounce per gallon of water and dilute downstream 10:1. Adjustments in dilutions should be made based upon each customer's particular equipment and washing style.
