Heavy Duty Cleaner for Vegetable and Fatty Soils*

General Description

AVO 2 is a biodegradable, alkaline, water-based blend of nonionic detergents, solubilizers, chelators, penetrants and builders designed for cleaning burnt oils and grease typically found in kitchen venthoods. **AVO 2** is specifically formulated for removing tough soils from restaurant vent hoods and other tough cleaning jobs. **AVO 2** thoroughly penetrates to eliminate grease, fat, soy oils, and other hard to clean soils. Depending upon the degree of its dilution with water, **AVO 2** is an effective general purpose cleaner for kitchen floors, counter and stove tops. When used properly, **AVO 2** will greatly reduce the possibility of a vent fire from accumulated oils and grease in the exhaust system. **AVO 2** is a powerful cleaner and eye and skin protection should be worn when using this product. **AVO 2** is safe and effective for use in non-food cleaning processes as per 9 CFR 416.4 (see below).

Application

AVO 2 is highly concentrated. **AVO 2** can be applied as provided or can be diluted with water to desired concentration for best results. Industry standard application equipment can be used to apply product in concentrate or diluted form. Adjust concentration for soil conditions. Use as provided directly onto vent and filters and allow 15 minutes dwell time to penetrate the soils. Dilute with water from 20 to 50:1 for general cleaning.
